

Registration For YMCA Session Starts Monday

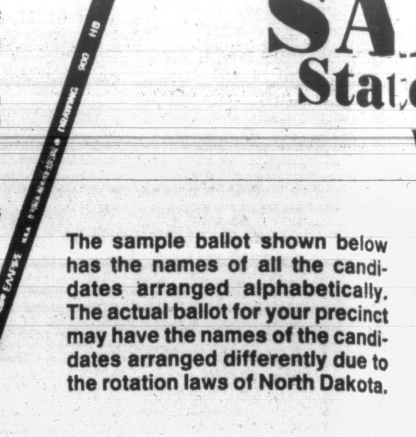
The Minot Family YMCA will be holding registration next week for its Winter I session. YMCA members can register Monday and non-members on Tuesday.

INSTRUCTIONS FOR VOTING THE PAPER BALLOT

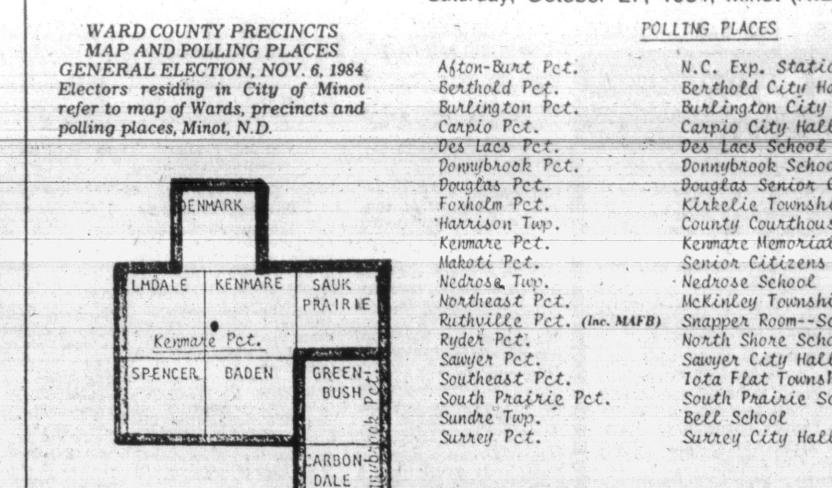

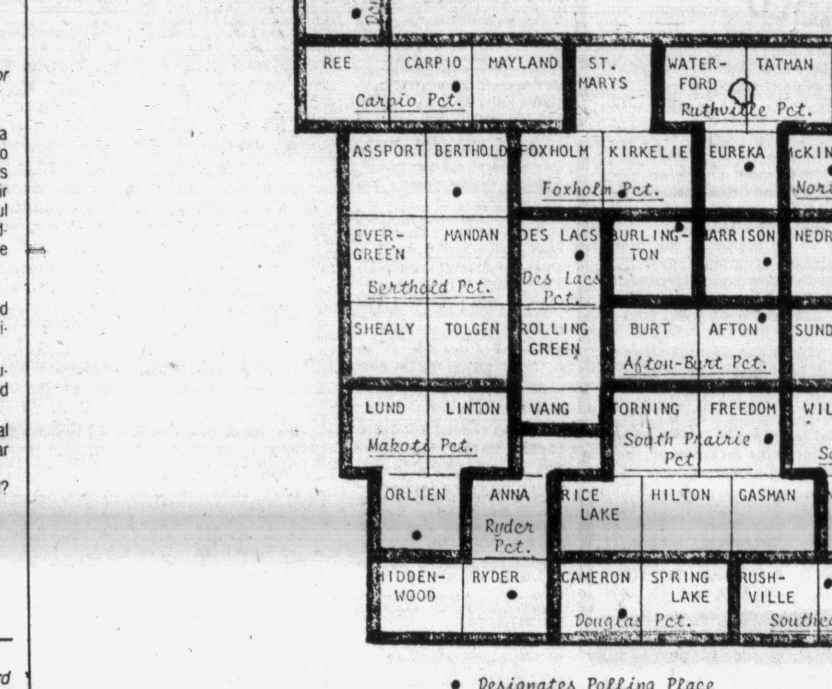

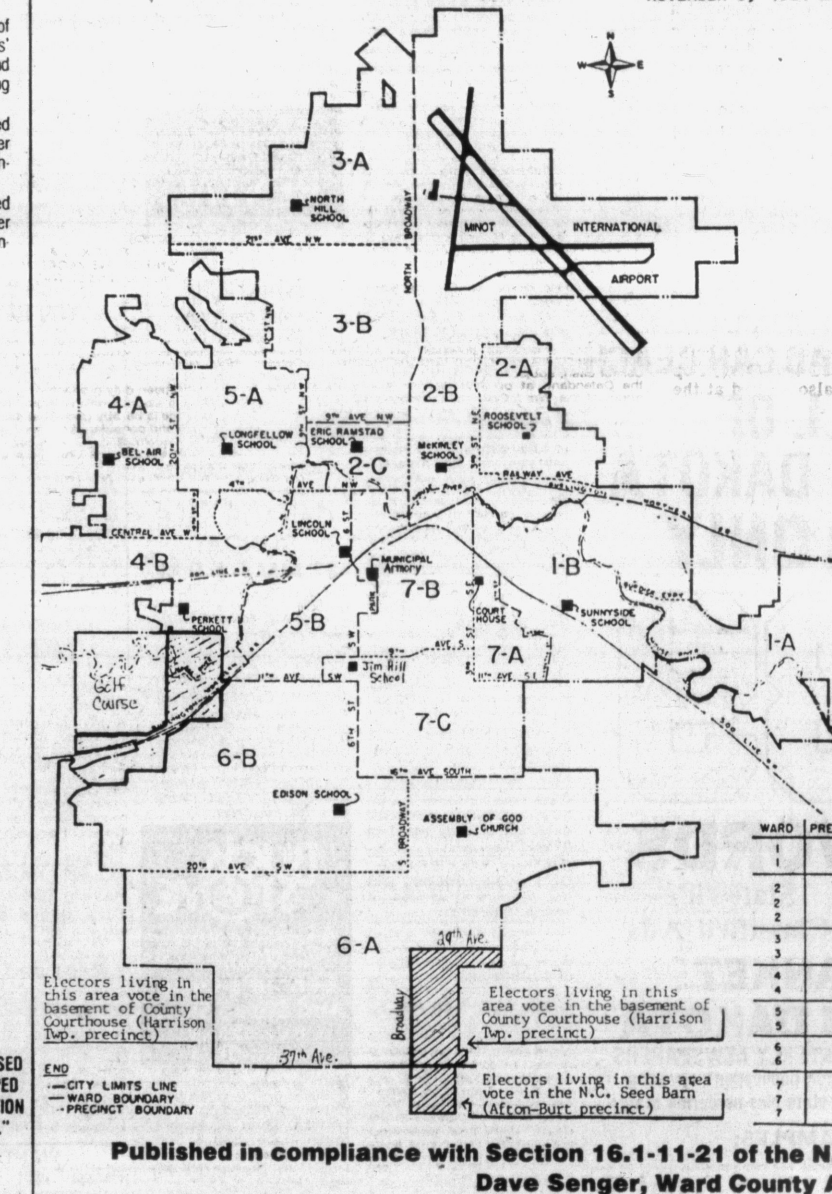
