No. 3 Initiated Constitutional Amendment:

To change the name of the institution of higher learning at Fargo from "The Agricultural College at the city of Fargo in the County of Cass", as it is now known, to "The North Dakota State University of Agriculture and Applied Science at the city of Fargo. in the County of Cass".

Submitted by initiative petition providing for the amendment of Section 215, subsection 3, of the Constitution of the State of North Dakota relating to changing and establishing the name of the North Dakota Agricultural College by omitting the words "The Agricultural College at the City of Fargo in the County of Cass" and adding the words "The North Dakota State University of Agriculture and Applied Science at the City of Fargo, in the County of Cass."

BALLOT TITLE:

An initiative Petition to amend and reenact the Third Paragraph of Section 215 of Article XIX of the Constitution of the State of North Dakota to change the name of the Agricultural College to "The North Dakota State University of Agriculture and Applied Science."

BE IT ENACTED BY THE PEOPLE OF THE STATE OF NORTH DA-KOTA:

Paragraph Third of Section 215 of Article XIX of the Constitution of the State of North Dakota, as amended, is hereby amended and reenacted to read as follows:


